## **SAVE THE DATE for the Federal Fiscal Year (FFY) 2017 Homeland Security Grant Program (HSGP) Information Seminars**

The Arizona Department of Homeland Security (AZDOHS) will be holding FFY 2017 Grant Information Seminars in Phoenix Metro Area, Tucson, and Flagstaff in early-January. At each seminar, staff from AZDOHS will be presenting an overview of the FFY 2017 application process which will include changes to the FFY 2017 **web-based** application and the **State Preparedness Report (SPR)**.

The SPR has become the metric by which all projects will be measured. In order to obtain a deeper understanding of the Core Capabilities, the SPR and how to write a successful application you should plan on attending this seminar.
